



ROUTINE CARE

Most Parkland™ ceiling tile products feature a textured finish to help protect and beautify the surface. For smooth products, extra care is recommended in handling and cleaning the surface to prevent mars or scratches from occurring. Soapy water, ammonia-based cleaners or common household surface cleaners will remove most dirt and residue from products. Please note that while all Parkland ceiling tile products are extremely resistant to water, only SpectraTile™ brand products are recommended to total saturation or immersion in water during cleaning. Stubborn residue will require a little stronger cleaner. Follow the recommendations below, in order, to properly clean your ceiling tile product. Always test in an inconspicuous area first.

STAIN REMOVAL:

- Warm soapy water, wipe with damp cloth
- Ammonia based liquid cleaner
- Tip: Wipe dry after cleaning to prevent a build-up of soap residue, which can create the appearance of light scratches over time.

SpectraTile can be pressure-washed with mild detergent with excellent results. **[Use a fan spray pattern, pressure under 1000 PSI and keep nozzle at least 18" from surface of tile]** Test pressure settings and distance from the nozzle to the tile surface for good results prior to commencement of pressure-washing as excess pressures can damage surface finish.

RESTORATION:

CEILING TILE surfaces may be repaired or restored in some cases

- Dinged edges on SpectraTile may be restored with medium or fine sandpaper or a laminate file, follow up with fine sandpaper, and a White 3M Scotch-Brite® pad.
- Scratches or mars on SpectraTile may be buffed out in some cases by wet-sanding with 220-600 grit paper, in multiple steps. Polish with toothpaste, Armor-All® or car polish, and rinse.
- For damaged MagnaTile™, discard and replace.

SANITIZING:

- SpectraTile and Magnatiles are amenable to sanitizing procedures. Follow Sanitizing instructions set forth by governing body, and test in an inconspicuous area first. Contact Parkland for more information.

AVOID:

The use of non-recommended cleaners may cause surface damage and should not be used on Parkland ceiling tile surfaces. Some chemicals are not compatible with ceiling tile products, avoid contact with: Chloroform, Ketones, strong bleach solutions, acid-based cleaners, and other harsh chemicals.

Surfaces exposed to these agents should be promptly flushed with water. Contact for even a short period of time can cause surface damage, spots, or discoloration. Follow the recommended restoration procedures described above as needed to its original condition. Severe damage caused by incompatible chemical contact will require product replacement.
